## Chief Report

Calls: 17 total calls, 2 Fire Calls, 5 EMS calls, 2 MVA's, 4 Mutual Aid Calls and 4 Service calls.

**Staffing and Recruiting:** We are down to 15 from 22 in our recruit fire academy. An employer has been threatened at the prospect of community service for one of our recruits. This recruit has backed out of CVA22-02 academy due to large workload given from employer. Our 10 recruits are doing very well academically, skills are hit and miss. We are working on skills and getting the class used to the testing process. We have been getting inquires for 2023 Fire Academy. We are not sure when our next academy might begin. We are encouraging those who are not EMT's, to investigate finding a class. We can put them to work if they do until academy starts.

## **Financial Report:**

**Training:** We have a new training Captain and tonight will be his first drill with the fire fighters. Captain Fitzgerald PhD has been in the fire service for 42 years and is the chemist for the Pierce County Hazardous Incident Team (PCHIT). He has been with our department since March of 2019, he had been with East Pierce Fire & Rescue. Training has been in-person but poorly attended. We have North Bend scheduled for the end of the month and we are hosting a Fire Officer II test this month. We have started a new quarter and those who had asked for personal time off are coming back

**SS911:** I have not been to any of the meetings. Staffing the last 2 weeks of the last quarter kept me close to home.

**Fleet Status:** My command vehicle is in the shop currently. We hope that it might be finished this week. I need to find a couple of radio chargers for the center console. We had, with the help of Retired Chief McCollum, BR76 loaded on a truck and delivered to the transmission shop in Tacoma. The truck was diagnosed, and it a needed transfer case. They rebuilt the transfer case and went through the transmission. Both front and rear differentials. The running gear is now serviced and ready. I can now see what is available about replacing the Ford part of the truck. We still have 2, 12-gallon gas tanks which is not ideal but for now will work.

**Good of the Order:** As we say goodbye to B/C Sandstrom, we are excited to say hello to Captain Fitzgerald PHD. We look forward to what he can bring to our fire department. In his time here he has been our HazMat instructor with the last 4 or 5 academies. B/C Sandstrom will continue to work with this current academy on the fire side until it is completed in December. This will give this group continuity from start to finish with a consistent message and learning style. We are going to start planning out our Santa Runs. Santa will be brought to the BPIC and very soon, Trunk or Treat at the BPIC. Dash Point Christmas Tree raising and the BPIC's when they are ready. The Turkey Trot will be on Thanksgiving morning. We will see how many of our recruit class I can get to run/walk it with me this year.
