Chief's Report

Calls: 20 total calls, 2 fire calls, 16 EMS calls, 0 MVA's, and 2 Service Calls, A76, had 3 transports, Olympic had 9, all ALS.

Staffing and Recruiting: We will have an opportunity for two fire academies in 2024. I received a phone call from South Pierce Fire & Rescue. They have been authorized to hold a spring academy. We will hold a fall academy starting in August for the second. We attended a

job fair at TCC, and we have several inquiries for both fire academy and EMT. We will start to gauge the applications to see where they would like to start.

Training: Chief Rapozo and crews have been preparing the house on Ton A Wan Da for the upcoming burn this Saturday, 11/18. We have been using the house for search and hose drills. The final prep from the developer will happen today and tomorrow. Chief Rapozo and I will be reviewing the Incident Action Plan. Saturday will start at Station77 at 0700.

SS911: Nothing to report, I did not attend any of the meeting last month.

Fleet Status: R77 is the last of our fleet that needs servicing. I want her to go to Ford for the service. We received 2 recall notices and I want them followed up on. E77 is back at West Pierce for the parts ordered to complete her service. We should have her back before the burn on Saturday. There are a couple of items for E76 ordered to complete her service.

Good of the Order: The Department will be having our Holiday Potluck dinner next Tuesday night for drill. You are invited to break bread with the troops. During the Commissioner's Conference, we were a sight on the 12th floor. Commissioner Zuluaga and I with the representatives from Rosenbauer were hanging around the baby grand piano going over the change order for our new engine. We will discuss it later this morning. I have ordered some equipment for A76. A new power cot and a performance loader will help us guide the cot into position and at the same time keep the cot charged. Braun NW has quoted us a price to install the loader. I also bought a battery powered auto extrication cutter. This cutter will get us started moving away from the gas-powered extrication. This cutter has more power to cut the exotic metals that the car companies are coming out with. Captain Fitzgerald is completing his purchases of the Hazardous Materials equipment with the grant from the Puyallup Tribe of Indians. We need to help with some of the costs, we needed a calibration station to make it all work. Next is to clean out the radio room so it all has a safe place to live and be ready.

Craig Williams has been hired as MSO.
